# What is TOP?





### What is TOP?

TOP funds creative projects that will reduce the number of single occupancy vehicle trips and/or congestion on the region's roadways - a concept known as Transportation Demand Management (TDM).

#### What type of TDM strategies?

- Provide travelers with effective, reasonable, and affordable choices to improve travel and reduce use of Single Occupancy Vehicles (SOVs)
- Make transit and traffic more reliable
- Encourage use of active modes of travel



### Two-stage application process

- Expression of Interest (EOI): Due 1/24/22
- Longer Application (only with invitation): Due 3/9/22



### **Elements of TOP**

#### What are we looking for?

- Innovative TDM strategies
- Projects that can spend the money within the 2-year timeline
- Collaboration and coordination across and between agencies, counties, and states in the DVRPC region

#### Who is eligible for TOP funds?

- Transportation management associations (TMAs)
- Nonprofits
- Government organizations/agencies
- School districts or schools
- Transit agencies



### Elements of TOP

#### What are the categories of projects?

- Capital projects
- Operating projects
- Education and marketing campaigns
- Planning is eligible but ONLY if it leads to implementation within the project timeline

#### What are the funding sources?

- Surface Transportation Block Grant (STBGP) funds for most of the region (PA and NJ)
- NJ Congestion Management and Air Quality (CMAQ) funds outside the Philadelphia Urbanized Area
- TOP requires a 20% match



# **Total Available Funding**


- \$2,293,000 in PA by May 31, 2024
- \$400,000 in NJ\* by May 31, 2024
- Minimum project cost \$75,000
- Maximum project cost \$600,000



# Philadelphia Urbanized Area (NJ)

Projects selected by the Review Committee with areas outside of the Philadelphia Urbanized Area must use CMAQ funds.

\$100,000 is available for these projects

# "A New Route to Better Travel for All: The Regional TDM Plan"

#### Submissions must meet at least two goals:

- Climate Action and Air Quality Improvement: Contribute to air quality conformity for the region
- Equity: Improve access to opportunity for communities of concern
- Reliability: Make trips by all modes more reliable, specifically during peak periods
- Freedom of Choice: Enable multiple, quality modal options
- Affordability: Improve affordability of non-SOV travel options



# Expression of Interest (EOI)



### The Travel Options Program (TOP): Expression of Interest

Imagine a region of connected communities, where residents and workers don't need cars and have the freedom to choose from multiple reliable, affordable, safe, and well-connected transportation options. How do we make that vision into a reality? Work with us to develop it!

We are seeking new and innovative ideas that will reduce the number of single occupancy vehicles – people driving alone to work, school, or errands – on the region's roadways. Project ideas must respond to the goals, outcomes, and strategies established in A New Route to Better Travel for All: The Regional TDM Plan, available at <a href="https://www.dvrpc.org/TDM">https://www.dvrpc.org/TDM</a>.

The Plan identifies goals that address improving air quality, equity, reliability, affordability, and freedom to choose travel options. Applicants are required to estimate how many vehicle trips they will reduce if the project is implemented.

If your idea is selected, your organization will be asked to submit a more detailed proposal for a project budget that should be at a minimum of \$50,000 and cannot exceed \$500,000. The successful project will be funded through the federal Congestion Management Air Quality (CMAQ) program.

This form is due no later than Friday, January 22nd at 5:00 p.m. If your idea is selected, you will be asked to submit a longer proposal with more details, including a timeline and a budget. The full proposal will be due by March 19, 2021 at 5:00 p.m.





# Longer application - by invitation only

After EOI, some proposals will be selected for Stage 2, due March 9th. Guidelines will be posted on the TOP website by end of January.

#### Opportunity to explain more about your idea

- <u>Detailed scope</u> and specifics of proposed project
- <u>Budget:</u> labor/non-labor, overhead (etc.), design, construction, consultant costs (*any* cost that's applicable to your project), and how match will be met
- <u>Timeline:</u> Project tasks including an explanation of measured change
- <u>List of agency(s) applying</u> and principle staff to work on project
- Map of project area
- Meeting with county planning agency representative(s)
- Cover letter

# TOP Application Process Dates and Deadlines

Important Dates and Deadlines	
January 12, 2022	EOI information session
February 2 - February 14, 2022	EOI submittal review & applicant meetings
February 17 - March 9, 2022	Application open period
March 9, 2022	Full applications due
April, 2022	Staff to present to DVRPC RTC and Board TOP Project Slate for approval of FY 23-24 Projects
July 1, 2022	Work can begin on projects
May 31, 2024	Final project work must be complete
