- Regional Greenhouse Gas Inventory allocated to the county and municipal level (update due in early 2023)






Local Climate Action



- 45+ municipalities signed the **Ready for 100 Ordinance**
- Bucks, Chester, Delaware, and Montgomery counties + PHL have all developed or are developing Climate Action Plans
- At least a dozen PA municipalities have developed climate action plans or energy transition plans through DEP's LCAP, or through private or academic partnerships.






