SPEAKER BIOS

David Saunders

Director, Pennsylvania Department of Health, Office of Health Equity.



In May of 2016 David Saunders joined the Pennsylvania Department of Health as the Director of Health Equity. In addition to more than 30 years of non-profit management experience, David brings with him extensive knowledge in the fields of education, public health, disparities and youth development.

He has collaborated on health disparity reduction initiatives, developed cutting edge programs targeting underserved communities, and established state training institutes; collaborating with state, county and local officials.

He has a Bachelor of Science degree from Lincoln University and a Master's in Education from the Pennsylvania State University. He comes to the Commonwealth after serving as School Health Education consultant with the

California Department of Education and having held leadership positions at the American Cancer Society, and YMCA.

In April 2020 David took on the massive task of developing a collective response to COVID 19 and the implications of the pandemic on vulnerable populations in the Commonwealth. 15 population groups were explored from a variety of angles using 12 stakeholder groups with an eclectic membership including government, academia, non-profit, and healthcare. 69 recommendations were developed that seek to mitigate the effects of the pandemic both now and in the future. This group continues to meet with the hope to one day soon pivot to becoming an arm in the movement to eliminate health disparities.
