Good local model: Delaware -

At one of our partners' firms, they make an effort to stack eligible funding for their clients. Not all design consultants are doing this work though. They have made a decision to learn about several funding sources to offer municipalities. Once they understand the technical aspects of the project, they do the legwork to identify funding sources. It's really helpful for the engineers to also understand the funding process

RASCL program: Project guidance group - cohort of partners from many sectors that have a project need - can apply for "office hours". RASCL bring together the RASCL partners that are most appropriate to address that need/applicant to talk through the project or funding application

Equity is our priority but these communities are still falling through the cracks. EPA has funding opportunities for communities both big and small that are disadvantaged Philly responded that they could use help putting together a repository of all the funding mechanisms out there into a package.
